

# Superior Court of the County of Lassen

This document contains the court's responses to the questions we included in a survey regarding the services that the Administrative Office of the Courts (AOC) indicates providing to the courts. Our survey asked each of the trial courts, the courts of appeal, and the Supreme Court to indicate which services that each court has used. In addition, our survey asked each court to indicate whether or not it values each service. Other questions in the survey asked about the quality of the services that AOC provides and the importance of the services to the court's operations.

After the courts responded to our survey, we identified, in consultation with the AOC, eight services in our survey that do not apply to the trial courts. We excluded these eight services from the analyses that support the survey-related tables and figures that appear in our audit report.

#### **Q92: Additional Comments**

It would seem logical that the Judicial Council Staff may be more easily streamlined to serve the trial courts and support the Judicial Council if it was less cumbersome.

Over the years many times it has been observed and noted by some that it would make more sense for the JC to be located in the state capitol of Sacramento. Which of course would be less costly, at least for real estate. Secondly, with so many offices or departments listed above, why not consolidate down to 1) Trial Court Services and 2) JC Services within each of those you might then have Administration and Operations and beneath those of course are HR/Payroll/Procurement/Facilities/Security/IT/Legal all under Administration. Operations would have Judicial Support & Research/Appellate, etc. etc.

OR another option is to just have Judicial Council Staff and create an Administrative Dept. that handles all responsibilities related to the appropriate categories whether trial court or JC and so on for Operations, the operational staff would support any judicial officers, attorneys etc.

Just some thoughts "out of the box"....
