This document contains the court's responses to the questions we included in a survey regarding the services that the Administrative Office of the Courts (AOC) indicates providing to the courts. Our survey asked each of the trial courts, the courts of appeal, and the Supreme Court to indicate which services that each court has used. In addition, our survey asked each court to indicate whether or not it values each service. Other questions in the survey asked about the quality of the services that AOC provides and the importance of the services to the court's operations.

After the courts responded to our survey, we identified, in consultation with the AOC, eight services in our survey that do not apply to the trial courts. We excluded these eight services from the analyses that support the survey-related tables and figures that appear in our audit report.

Additional Comments

We rely on the coordination and support role for the Self Help and Justice Corp programs. Given staffing reductions of the past several years, we were only able to continue essential functions because of Justice Corps, and the recruitment, training and coordination role played by the AOC was critical. Allows the trial court to refer customers to online, self-help materials. Additional Comments

Fiscal Services have been integrally important to the trial courts. As State budget cuts and additional reporting mandates have been piled on to the trial courts, the need for accurate financial reporting, greater assistance to trial court accounting staff has become paramount. Trust and Treasury services have become more important as revenue distribution requirements and attention to cash flow requirements have increased. Court staff rely on contract and procurement assistance and Fiscal training to ensure they comply with JBCM, and follow audit guidelines. We've had some interactions with the Enhanced Collections Unit over the years pertaining to questions about the collection of outstanding traffic and criminal fines/fees. Overall, experience has been positive but sometimes the response time in getting information could be improved upon. Seems like a very busy unit with a certain level of turnover. We understand that we have repeated the following message throughout this survey. This is because it is primary to the message and input we have provided internally to AOC leadership, with limited response and productive change over the past five years.

The Chief Justice's SEC Report was appreciated, with productive actions that followed. But in our view, they were too limited and did not eliminate the culture of protection, limited perspective and denial that still exists with some in AOC leadership.

To be specific, Judge Jahr and Jody Patel have done much good and have demonstrated a willingness to respond to these issues. More needs to be done. Unfortunately, the actions of Curt Soderlund and Curt Childs demonstrates a lack of reasonable management oversight, leadership and productive response. They also appear to be more a part of "the problem" (lack of transparency, failure to address management deficiencies, committed to maintain the status quo) rather than a productive solution. They (and others who are responsible for the lack of appropriate management oversight listed below) need to be held reasonably accountable.

Re-establish credibility and trust. Demonstrate reasonable management oversight and accountability - at all levels. We also believe that the process for appointments to the Judicial Council needs to be further democratized.

We state once again:
